Nominations received for each category of awards will be judged by the Awards Selection Committee consisting of the members from Government, Academia and Industry in three stages viz. Stage-1 - Evaluation of Nomination Documents, Stage-2- Digital Dialogue for Field Validations, Stage-3- Expert Deliberations.

Nominees will be required to give presentations in Stage-2 through virtual mode only.
